For future classes (and perhaps to write to previous speakers), here is a question that seems to me very important to ask of the visiting speakers: "How does your journey through the Vietnam era make you stronger?" And, "How can the events of the Vietnam era make our national community stronger?" Or, "What were the good results from all the turmoil of the Vietnam era?"
